- ❖ No changes will be made over the answering machine you must speak with an individual
- ❖ Even if you would like your hair down, if it requires the use of a flat iron or curling iron then it is considered an up-do and will be charged as such.
- ❖ A \$30.00 prepayment for hair and a \$24.00 prepayment for makeup is to be paid **before** Salon Louie will schedule the appointment to guarantee your date and appointment. This can be done as one ticket or individuals within your wedding can call and prepay for their appointment.

Cancellations. Any cancellation made with less than 14 days notice will be charged to the credit card associated with this contract. The entire cost of the cancelled service(s) will be placed on the credit card.

Late Arrivals. If a wedding party is more than a **15 minutes late** without making contact with Salon Louie, the assumption is the client is a no-show. In this case, the client forfeits all deposits. If a wedding party or wedding party member is late for the scheduled appointment time and notifies Salon Louie of a new arrival time, stylists may or may not be able to accommodate the new arrival time or services. With this being said, clients are liable for the original amount of their scheduled appointment even if the stylist is unable to accommodate all of their scheduled services due to them being late.
